

# PRIVACY & COOKIE POLICY



## Farnsfield Local History Society (FLHS)

At Farnsfield Local History Society (referred to as “FLHS”, “we”, “us”, “our”), we understand that your privacy is important to you and that you care about how your information is used and shared online. We respect and value the privacy of everyone that visits our website and only collect and use information in ways that are useful to you and in a manner consistent with **your rights** and **our obligations** under the law, including the General Data Protection Regulation (GDPR).

**WHAT INFORMATION DO WE COLLECT:** We collect information about you when you email us via the contact form on our website. Website usage information may be collected using cookies.

If you no longer wish to be contacted for marketing purposes, please email using the contact form and clearly state you wish to opt out.

**HOW DO WE STORE YOUR DATA:** We only keep your data if we have a valid [legal reason to do so](#) and will only keep it for as long as we need to in order to fulfil our contractual or legal obligations or for as long as we have your permission to keep it.

**ACCESS TO YOUR INFORMATION AND CORRECTION:** You have the right to request a copy of the information that we hold about you. If you would like a copy of some, or all of your personal information, please email using our contact form. We may make a small charge for this service.

**COOKIES:** Cookies are text files placed on your computer to collect standard internet information and visitor behaviour information. This information is used to track visitor use of the website and to compile statistical reports on website activity.

You can set your browser not to accept cookies and can also remove cookies from your browser. However, if you do, some features on our website may not function as a result.
